The committee is given the mandate to conduct the elections for the Mess Committee following the Mess Committee Rules in free and fair manner. The Mess Committee Rules are placed in the following link.

The Mess Committee consists of 24 elected members who are students residing in the hostel and members of the respective messes. The composition of the committee is as indicated below:

Vegetarian 'A' Mess: 4 membersVegetarian 'B' Mess: 4 membersVegetarian 'C' Mess: 4 membersVegetarian 'D' Mess: 4 membersVegetarian 'E' Mess: 4 membersNon-Vegetarian 'B' Mess: 2 membersNon-Vegetarian 'C' Mess: 2 members

- The term of the elected mess committee is one year.
- Each of the messes will form a constituency for electing its representatives. However, in the composite messes 'B and 'C', the non-vegetarian members are also eligible to cast their votes for electing the representatives for the vegetarian side (as the vegetarian food is common to both the wings), only non-vegetarian members shall be eligible to cast the vote for electing non-vegetarian representatives.
- The elected members of the mess committee shall elect the President and the Vice-President from amongst themselves.
- A member elected or nominated for the mess committee for one term or part of the term is not eligible for election or nomination in the next term (i.e. for one year). However, since this new rule came in to effect from this year only, the Administration decided to allow a one-time opportunity for the previous committee members who had served for only one term (six months) also to contest the elections.
- Day boarders are not eligible to vote in the election of the mess committee.
- Residents who have not cleared their hostel and mess dues by the prescribed dates are not eligible to contest the election for mess committee or for proposing or for seconding

a nomination. The proposer and seconder of a nomination should also be the members of the same mess.

- Final-year students are not eligible to contest in the elections.

Definition of Final Year:

UG Program: 4th year ongoing Master's Program: 2nd year ongoing Int PhD Program: 7th year ongoing Ph D Program: 5th year ongoing

The Election committee hereby notifies the election to the above constituencies, online through "Election Buddy" App. The voter list will be published on the notice board of the respective messes before 27 October 2023. Any objections on the voter list shall be made before 5.00pm on 27 October 2023.

An email will also be sent to all members eligible to vote in this election. The details of whether the voter can contest in the election or propose and second the nomination will also be mentioned in the email.

The interested members of the respective messes who have no dues can submit their nominations along with signatures of first proposer and second proposer. The filled in nominations with a photograph of the contestants shall be dropped in the box meant for receiving nominations in the office of the CMC behind Hoysala House. The date of key events in the process are as follows:
